The Commission reviewed the application of Northern States Power Company (applicant) for approval of Voluntary Renewable Energy Rider Customer Service Agreements (CSAs) and made the following determinations:

2. The Commission approved the applicant's application as filed, including approval of the applicant's request delegating authority to the Administrator for the Division of Energy Regulation and Analysis the authority to authorize changes in subscription levels between subsidiaries owned by the same parent; assignment of contracts or a portion of a contract to a customer with an existing contract; assignments of contracts or a portion of a contract to a new customer with equivalent credit rating with materially the same contract provisions; or assignment of contracts or a portion of a contract between existing customers whose CSAs have been approved by the Commission such that the Project remains fully subscribed.

The Commission directed the Division of Energy Regulation and Analysis to draft an order consistent with its discussion.

6680-AF-107 - Request of Wisconsin Power and Light Company for Deferral of Construction Cost Overruns Associated with Solar Generation Projects Authorized in Docket 6680-CE-182 and 6680-CE-183

Commissioner Nieto is recused from discussion on this item.

The Commission directed the issuance of an Order to Reopen, Notice and Request for Comment in this docket describing the Commission's intent to modify its Final Decision issued on February 16, 2024 in order to authorize Wisconsin Power and Light Company (WP&L) to defer the financing costs associated with the solar project cost overrun in the estimated amount of \$25.4 million, without carrying costs and with the following conditions:

- 1. Authorization is for accounting purposes only and does not bind the Commission to any specific treatment in any future proceeding.
- 2. Authorization is conditioned upon WP&L committing to propose using securitization pursuant to Wis. Stat. § 196.027 (or assuming the revenue requirement equivalent of securitization) to address the recovery of its share of the scrubbers and baghouses at the Columbia Energy Center starting 12 months from the date that Columbia ceases the use of coal.

If no comments are received opposing the proposed changes, then the Secretary to the Commission is directed to sign a Final Decision on Reopening on behalf of the Commission effecting the changes outlined above.

If comments in opposition to the proposed changes are received, Commissions staff shall return the matter to the Commission for further consideration. Minutes and Informal Instructions of the Open Meeting of Thursday, August 15, 2024 Page 6
