Minutes and Informal Instructions of the Open Meeting of Thursday, April 18, 2024

The Public Service Commission of Wisconsin (Commission) met as noticed. Present were Chairperson Strand, Commissioner Nieto and Commissioner Hawkins.

#### **Minutes**

5-AE-249 - Application for Approval of an Affiliated Interest Agreement between American Transmission Company LLC and Wisconsin Power and Light Company for Work Related to the Rock County Reliability Project

The Commission approved the Notice of Investigation and directed it to be signed by the Secretary to the Commission.

### 5820-UR-117 - Application of Superior Water, Light and Power Company for Authority to Adjust Retail Electric, Gas, and Water Rates

The Commission approved the Notice of Proceeding and directed it to be signed by the Secretary to the Commission.

### 1-IC-558 - Application for Intervenor Compensation filed by RENEW Wisconsin to Participate in Docket 5780-TE-111

The Commission approved the request of RENEW Wisconsin for intervenor compensation in the amount of \$8,000 for its participation in Docket 5780-TE-111.

The Commission directed the Division of Energy Regulation and Analysis to draft an order consistent with its discussion.

9300-PLI-127 - Investigation of the Complaint of ANR Pipeline Company against Bloy Concrete Contractors, LLC, Referred to the Commission Pursuant to Wis. Stat. § 182.0175(3)(br)2.

#### **Proposed Consent Agreement**

The Commission agreed to dismiss the complaint by joint execution of a consent agreement between Bloy Concrete Contractors, LCC (Respondent) and the Commission, accepting the proposed Consent Agreement as drafted, which required the Respondent to attend the education course under Wis. Stat. § 182.0175(3)(br)4. and pay a \$6,000 forfeiture to the Commission and \$600 surcharge to Diggers Hotline, Inc. within 45 days of the effective date of the Commission's Order approving the Consent Agreement.

The Commission directed the Division of Energy Regulation and Analysis to draft an order consistent with its discussion.

## 1140-TG-109 - Application of City Gas Company for Approval to Implement a Renewable Natural Gas Pilot Program Tariff

The Commission approved the application of City Gas Company (applicant) for approval to implement a Renewable Gas Pilot Program (RNG) Tariff with the following conditions:

- 1. The applicant shall work closely with the Commission's Pipeline Safety Team to ensure Commission staff is adequately informed and receives timely results of the RNG testing.
- 2. The applicant shall work with Commission staff to develop standard reporting requirements related to safety and testing, including the frequency of reporting.

The applicant shall also adhere to the following additional reporting requirements:

- 1. Number of customers enrolled in the program;
- 2. RNG production by customer by month;
- 3. Number of customers interested in the program;
- 4. Production per customer compared to minimum production required;
- 5. Costs and incomes relative to forecasted budgets.

The Commission directed the Division of Energy Regulation and Analysis to draft an order consistent with its discussion.

# 9705-FG-2024 - Project Year 2024 State Energy Program Formula Grant Awarded by the US Department of Energy

#### Proposed State Energy Program Project Year 2024 Annual Plan

The Commission approved the proposed State Energy Program Project Year 2024 Annual Plan.

The Commission directed the Division of Digital Access, Consumer, and Environmental Affairs to draft an order consistent with its discussion.

### 5-NF-2024 - Universal Service Fund Grant Program for Telecommunications Access Programs or Projects by Nonprofit Groups

#### **USF Nonprofit Access Grant Program Awards**

The Commission reviewed the applications for the 2024 Nonprofit Access Grant Applications and made the following determinations:

- 1. The Commission determined that the application from Marquette-Adams Telephone Cooperative, Inc. was not eligible for funding pursuant to Wis. Admin. Code § PSC 160.125(2)(c)1.
- 2. With regard to other eligibility issues such as those associated with the appropriate match ratio, the Commission took note of the concerns regarding eligibility of the applications identified in Table 1 of the memorandum date April 8, 2024, but found it unnecessary to make specific eligibility determinations. The Commission directed staff, in the future, to work with applicants on potential eligibility issues at the time of submission.
- 3. The Commission reviewed the 2024 applications for the Nonprofit Access Grant Program and grants to the following amounts to the applicants listed below:
