Application of Wisconsin Electric Power Company for Approval of Accounting Treatments for Investments to be Made in Distribution Facilities to be installed in the Village of Mount Pleasant in Racine County, Wisconsin

APPLICATION

Background

Wisconsin Electric Power Company ("Wisconsin Electric" or "the Company") will be commencing construction of distribution facilities, including transformers, breakers, relays and other ancillary equipment ("Distribution Project") in the Village of Mount Pleasant in Racine County, Wisconsin.¹ To meet its customer's electric service needs this construction work needs to be initiated no later than June 2024. Timely construction of the Distribution Project is critical to maintain project timelines and ensure continued business growth and economic development within the EITM Zone. The Distribution Project will require a significant level of investment – the Company's current estimate for the construction and related costs for the Distribution Project is in the range of \$300 - \$350 million. Additionally, due to factors outside of its control, Wisconsin Electric has also needed to begin making deposits for long-lead time and high-cost equipment such as transformers.

Wisconsin Electric's current project budget estimates, by cost category and area within the EITM

All estimates are expected to be capital, with none of the costs projected to be operations and maintenance. More precise estimates will become available as the procurement process continues and firm pricing is provided by equipment suppliers and contractors through firm bids and the Company's issuance of purchase orders. The Company will supplement this estimate as additional information becomes available. Because the customer's forecasted load characteristics are still being refined the costs to be funded by contributions from the customer to be served has not been determined.

Accounting Request

Wisconsin Electric respectfully requests authorization to accrue Allowance for Funds Used During Construction ("AFUDC") on 100 percent of the construction work in progress ("CWIP") balance during the procurement of the equipment and construction of the Distribution Project. This authorization, if approved, will allow the Joint Applicants to finance these necessary and time-sensitive investments supporting substantial economic development in Wisconsin.

Wisconsin Electric further respectfully request that the Commission authorize the requested accounting treatment prior to [June 1, 2024] to allow Joint Applicants the opportunity to implement the requested accounting prior to making the first investments in equipment needed to
