NOTICE IS GIVEN that the Commission will hold a prehearing conference in this docket on Wednesday, November 3, 2021 - 1:00 p.m., and continuing at times to be set by the presiding Administrative Law Judge (ALJ).

This prehearing conference provides an opportunity to comment on: (1) who, other than parties already identified, will actively participate as parties, (2) the issues, (3) the schedule, and (4) any other matter that will facilitate the proceeding. Parties will be bound by the designation of issues and the schedule adopted at the conference.

This prehearing has no physical location. Parties and Commission staff appear by audiovisual connection over the internet, or may use the audio-only telephone connection, if no adequate internet connection exists. Anyone may observe by audiovisual connection over the internet, or by audio-only telephone connection. In addition, the Commission will livestream the audio of this hearing on its website.

Upon connecting to the hearing, each participant will enter a waiting room and await admittance to the hearing. Before commencing the hearing, the ALJ will admit each participant who connected before the designated start time. The ALJ will admit each participant who connects after the hearing begins at the earliest opportunity that does not disrupt the hearing.

 2. Were the determinations by Wisconsin Public Service Corporation and Wisconsin Power and Light Company to waive their respective rights under the Right of First Refusal as to Dominion Nuclear Projects, Inc.’s transfer of Dominion Energy Kewaunee, Inc.’s stock to EnergySolutions, LLC, reasonable and prudent?
