**NOTICE OF HEARING**

**NOTICE IS GIVEN** that the Public Service Commission of Wisconsin will hold a public hearing in this proceeding. There will be two separate hearing sessions, one for parties admitted to the proceeding and one for members of the public. The presiding Administrative Law Judge (ALJ) may allot additional time to receive evidence and comments, if necessary.

This is a Class 1 proceeding as defined in Wis. Stat. § 227.01(3)(a).

**Party Hearing Session**

On Wednesday, March 2, 2022, at 10:00 a.m., the Commission shall receive evidence from the parties and Commission staff. Parties and Commission staff appear by audiovisual

connection over the internet, or may use the audio-only telephone connection, if no adequate internet connection exists. A member of the public may observe by audiovisual connection over the internet, or by audio-only telephone connection. In addition, the Commission will livestream the audio of this hearing on its website.

### **Public Hearing Session**

On Thursday, March 3, 2022, at 2:00 p.m., and 6:00 p.m., the Commission shall receive comments from the public. A member of the public who wishes to comment appears by audiovisual connection over the internet, or may use the audio-only telephone connection, if no adequate internet connection exists. Alternatively, a member of the public may submit a written comment. Anyone may observe by audiovisual connection over the internet, or by audio-only telephone connection. In addition, the Commission will livestream the audio of this hearing on its website.

Upon connecting to the hearing, each participant will enter a waiting room and await admittance to the hearing. Before commencing the hearing, the ALJ will admit each participant who connected before the designated start time. The ALJ will admit each participant who connects after the hearing begins at the earliest opportunity that does not disrupt the hearing. Each member of the public shall remain muted until the ALJ invites that person to comment.

Each participant shall provide the participant's name, and status as either a party representative, Commission staff, or a member of the public. Each participant using the internet connection shall provide this information in the "Join Meeting" dialog screen, or by renaming the participant's screenname after gaining admittance to the hearing. Each person connecting by telephone shall provide the same information immediately after gaining admittance to the hearing.

The Commission will livestream the audio of this hearing on its website. The livestream allows anyone with an adequate internet connection to listen to the hearing without joining to it. To access the livestream, go to the Commission’s website at <http://psc.wi.gov>, and select “Live Broadcast” button.<sup>2</sup> The live broadcast webpage provides neither: (1) an opportunity to make a comment, nor (2) closed captioning.

**DOCUMENTS.** All documents in this docket are filed on the Commission’s Electronic Records Filing (ERF) system. To view these documents: (1) go to the Commission’s E-Services Portal at <http://apps.psc.wi.gov>, (2) enter “9812-EI-100” in the box labeled “Quick Single Docket Search,” and (3) select “Documents.”<sup>3</sup> To receive electronic notifications when new documents are filed in this docket, go to ERF - [EZ Subscriptions](#) and follow the instructions to subscribe to this docket.

On the next page, select the “File a comment” link that appears for docket number 9812-EI-100.<sup>5</sup> Web comments shall be received no later than Monday, March 7, 2022.
- **Oral Comment.** Speak at the public session. The ALJ may receive an oral comment from any member of the public in attendance at the Public Hearing Session. The ALJ

The Commission will not accept comments submitted via e-mail or facsimile (fax).

A person shall limit a public comment to non-technical personal knowledge or personal opinion. A person may include references to other materials in a comment, but may not include as part of a comment, any document not written or substantially modified by that person. The Commission shall only accept documents that a person offers to supplement a comment for the purpose of showing the basis of an opinion, not for proof of the matter asserted. Parties may object to the receipt of a public comment.

Any material submitted to the Commission is a public record and may appear on the Commission web site. Only one comment may be submitted per person during a comment period. The Commission may reject a comment that does not comply with the requirements described in this notice.
