Focus on Energy Delivery of Inflation Reduction Act Home Efficiency and Electrifications Rebate Programs

The Commission determined that Focus on Energy shall be the implementer for Inflation Reduction Act (IRA) funds from the Home Energy Performance-Based, Whole-House Rebates (HOMES) and High-Efficiency Electric Home Rebate (HEEHRA) programs. The IRA funded programs shall be managed as separate programs, not included in the Focus Portfolio. The fully detailed application for IRA funds to Department of Energy shall be reviewed and approved by the Commission.

The Commission directed the Division of Digital Access, Consumer and Environmental Affairs to draft an order consistent with its discussion.
