Re: Notification of Electric and Gas Customer Messaging Compliance Filing, Pursuant to Final Decision

Dear Mr. Stubley,

Northern States Power Company, a Wisconsin corporation ("NSPW" or "Company") makes this filing in compliance with the customer notification provisions in Order Point 3 of the December 20, 2023 Final Decision in Docket No. 4220-UR-126 (PSC REF #: 487255).

The Company will include the following message with the first billing reflecting the new rates:

The Public Service Commission of Wisconsin has approved new rates effective Jan. 1, 2024. Average residential electric bills will be about 0.2% more (less than \$1/month) in 2024 compared to the last rate change in January 2023. Average residential natural gas bills will be about 3.2% more (less than \$3/month) in 2024 compared to the last rate change in January 2023. Business customers will see similar changes based on their rate class, usage characteristics and type of service. (Docket No. 4220-UR-126)

In addition, the enclosed Residential and Commercial billing onserts will be included in all customers' bills in January 2024. The Outdoor Lighting rate folder has been mailed to all street lighting customers. Each of these publications will be posted on the Company's website.

Lastly, the Company has provided information on how to receive a complete schedule of authorized rates and rules to public libraries and pay stations located throughout the service territory and to customer-accessible Company offices.

A typical residential natural gas customer using 55 therms per month will see an increase of less than \$3 a month in 2024. Your bill shows separate charges for distribution (what we charge for delivering natural gas) and gas supply (what we pay to acquire natural gas). The Gas Supply Charge is adjusted monthly and approved by the Public Service Commission of Wisconsin. The Gas Supply Charge as of December 2023 is \$0.4201 per therm.

Natural gas service

The Public Service Commission of Wisconsin (PSCW) recently approved new natural gas rates. For most commercial and industrial customers, the increase will be about 2.7% for 2024. Your bill shows separate charges for distribution (what we charge for delivering gas) and gas supply (what we pay to acquire gas). The gas supply charge, shown below as of December 2023, changes monthly and is approved by the PSCW.
